China reports increasing elderly population

As China faces demographic crisis with rapid rise in population of old age people, the national capital is feeling the heat with numbers of pensioners climbing up to 23.4 per cent of about 22 million population.

The Beijing local government expects 30 per cent of the city's population to be aged 60 or above by 2030.

By the end of 2015, the elderly took up 23.4 per cent of the city's registered population, deputy head of the Beijing Civil Affairs Bureau Li Hongbing was quoted as saying by the Beijing Daily. Li said one in three registered Beijing

citizens will be over 60 in 2050. It is estimated that the city currently has 600,000 seniors with physical disabilities and 100,000 with mental disabilities.

In 2020, the city will pay out 200 billion yuan (USD 30.7 billion) in old-age pensions and the amount is expected to surge to 670 billion (about USD 111 billion) in 2030, Li said.

This year, the local government will roll out a 2016-2020 plan on the development of elderly care and a guideline on the development of industries targeting the elderly, state-run Xinhua news agency reported.

The ageing population will swell from 16.1 to 25.2 per cent in China which

could seriously test its social and economic development, a new data provided by the Population and Development Studies Centre at the Renmin University of China said last month.

The number of those aged between 16 and 59 will decrease to 896 million in 2020 and 824 million in 2030, while those aged 60 and over will grow to 253 million in 2020 and 365 million in 2030 the study said.

In a bid to shore up the numbers of the younger population, China this year has ended the three decades old one-child policy and replaced it with two child as the demographic crisis deepened with sharp rise in the population of old age population.

Kenya: Woman found alive six days after building collapse

Nairobi

A woman has been found alive after six days in a collapsed building and rescuers are working to free her, a Kenyan government official said.

Rescuers are creating room to release the woman who is speaking to medics waiting to treat her, said Pius Masai, the head of the National Disaster Management Unit.

"The medical team has administered IV, glucose has been administered. She is talking and in good spirits...we are taking our time to ensure she is removed safely," Masai said. The woman has been given oxygen and she is trapped in a small corner of her room, said Abbas Gullet, head of the Kenya Red Cross.

"We are very happy that even after six days, someone has been found alive," Gullet said. The death toll from the disaster has risen to 36 and 70 people are still missing, according to the Gullet.

A nearly six-month-old baby was rescued on Tuesday, raising hopes that more survivors would be found. The infant was found unharmed in a wash basin after the seven-storey building collapsed.

With housing in high demand in Nairobi, some unscrupulous developers bypass regulations to cut costs and maximise profits. After eight buildings collapsed and killed 15 people, President Uhuru Kenyatta last year ordered an audit of all the country's buildings to see if they are up to code. The National Construction Authority found that 58 per cent of buildings in Nairobi are unfit for habitation. Most of Nairobi's four million people live in low-income areas or slums.

David Cameron stands by criticism of Trump's Muslim comments

London: British Prime Minister David Cameron today stood by his criticism

of Donald Trump's vow to ban all Muslims from entering the United States, after an adviser to the presumptive Republican presidential nominee asked for an apology.

Cameron, who had dismissed the idea as "divisive, stupid and wrong" when Trump proposed it in December, told a press conference in London that it was clear that "the policy idea that was put forward was wrong". However, he said

the billionaire property tycoon "deserves our respect" for his victory in one of the most contentious and chaotic nomination battles in generations.

In the wake of a shooting by a Muslim couple in San Bernardino, California, that left 14 dead, Trump urged a "total and complete shut-down of Muslims entering the United States until our country's representatives can figure out what is going on".
